

CONSENT TO PERSONAL DATA PROCESSING

I hereby freely, willingly, and pursuing my own interests give my consent to the Autonomous Non-Profit Organization Social Innovation Support Centre located at: 4-2 Spiridonovka Str., Room 2, 123001 Moscow (hereinafter, the Company) to the automated and non-automated processing of my personal data, including using online services like Google Analytics, Yandex.Metric, LiveInternet, Mail.ru Rating, Google Doubleclick, Jivosite as per the list as follows:

- first name, patronymic name, last name, address, education level, occupation, contact information (phone number, fax number, e-mail, postal address), photos, other information,
- from where I enter the site <https://socchain.ru> (hereinafter, the Company Site) and information on the relevant web search or advertising queries,
- user device data (including resolution, version, and other attributes that characterize the user device),
- user clicks, page views, field completing, views and impressions of banners and videos, downloading of documents,
- data characterizing programmatic advertising segments,
- session parameters,
- data on the time of visiting,
- user ID stored in the cookies.

1. The terms used herein:

1.1. The Site shall stand for a set of texts, graphic elements, designs, images, program codes, photos and video footages, and other intellectual property items on the Web under the domain name socchain.ru.

1.2. The Site Administration shall stand for a person who has the rights to administer the Site.

1.3. The User shall stand for any person who has entered the Site and accepted the terms and conditions hereof, regardless of whether he was (not) registered and authorized to the Site.

2. Personal data use

2.1. By accepting the terms and conditions hereof, the User provides the Site Administration with his consent to the processing of his personal data.

2.2. Personal data are processed in order to receive feedback from those who visit socchain.ru and for promotional purposes.

2.3. The processing of personal data shall imply the following operations with personal data: collection, recording, classification, accumulation, storage, refinement (updating, modification), extraction, use, transfer (distribution, access granting), depersonalization, blocking, deletion, destruction of personal data.

2.4. By accepting the terms and conditions hereof, the User agrees to receive newsletters and ads by e-mail.

2.5. This Consent to Personal Data Processing shall be valid for an indefinite period of time, however, it can be withdrawn by the personal data owner by emailing a personal request to the Site Administration.

2.6. The Site Administration undertakes to use the User's personal data obtained as a result of using the Site as per the legal requirements on personal data protection, including Federal law No. 152-Φ3 of July 27, 2006 *On Personal Data* as amended at the time of processing such personal data.

2.7. Disclosure of Personal Data Personal data shall under no circumstances be disclosed to any third party unless so required by law. Besides, you can submit a request to unsubscribe from our newsletters, and we will handle your request without fail. You can unsubscribe at any time and completely remove your Name and E-Mail from the mailing list.

2.8. The User's personal data shall be processed and stored over an unlimited period of time in any legal manner, including as part of automated and non-automated personal data information systems.

I understand and acknowledge that:

- I hereby consent to the processing of my personal data specified when completing the feedback form on the Company Website, submitted (completed) using the Site;
- I may withdraw my Consent by submitting an application of optional form;
- The Company may be obliged to disclose my personal data if so required by law, court orders, authorized state agencies of the Russian Federation;
- Disclosing any personal data of third parties without their consent shall create liability in accordance with the current legislation of the Russian Federation.
